In the reference 2<sup>nd</sup> cited, orders were issued with Modified Medical Scheme to APTRANSCO/DISCOMs Employees/ Pensioners and their dependents/ Family Pensioners for reimbursement of medical charges as follows,

"A maximum ceiling limit of Rs.2.00 lakhs (Rupees Two lakhs only) is fixed for each time and each ailment separately for different major ailments/surgeries/treatments i.e., CABGS, Double valve replacement, Kidney Transplantation, Cancer, Neurosurgery, Aortic valve replacement, PTCA STENT be restricted to three spells for each of these diseases. Three spells means three surgeries for same ailment."

2. Now, consequent to requests received from the individuals and a clarification sought on whether the left over balance amount of ceiling of Rs.2.0 lakhs allowed per ailment of major disease per spell and are on followup treatment after the surgery for the same ailment, whether such balance amount may be allowed for reimbursement of followup treatment.

- 3. After careful examination of the issue, it is further clarified that the balance amount available out of a ceiling of Rs.2.0 lakhs allowed per ailment of major disease and are on followup treatment after the surgery of major ailment, the balance amount if any of the spell shall be allowed for reimbursement of followup treatment of bills in the first instance and there after exhausting of such amount further reimbursement if any shall be considered from life time ceiling limit of Rs.2.0 lakhs if available i.e., against the present procedure of booking expenditure of life time ceiling of Rs.2.0 lakhs only.
- 4. This order is issued with the concurrence of Director (Finance & Revenue) vide Regd. No.2168, dated:01-06-2012.
- 5. This order is effective from 08.04.2011.
