Consequent to reintroduction of medical scheme vide T.O.O Ms.No.301, dt. 31-3-2009 read with T.O.O (CGM/HRD) Ms.No.175, dt. 11-09-2015, TG Transco is following CGHS tariff rates of 2014 for various treatments/procedures under CGHS vide ref. 4th to 7th cited for reimbursement of medical bills, settlement of Credit Bills and for Issue of Credit Letters for the treatment of employees/pensioners / Artisans & their dependents and family pensioners. In the ref. 8th cited, the Ministry of Health & Family Welfare, Department of Health & Family Welfare, Directorate General of CGHS has revised the CGHS Package rates (total pages 331) w.e.f 13-10-2025.

2. After careful examination, the TG Transco hereby considers to implement CGHS 2025 tariff keeping in view of the increase in cost of surgeries/medicines etc., for reimbursement of medical bills and for issue of Credit Cards for the treatment of Employees/Pensioners/Artisans and their dependents and family pensioners.

3. This order shall come into force for the treatment taken on or after the date 13-10-2025.

4. The other orders relating to existing medical scheme issued from time to time holds good.
