Procedure for bid submission	<p><b>Procedure for Submission of Bids:-</b></p> <p>(a) The Bids should be in the prescribed form, which can be obtained from e-procurement platform from the date of electronic publication up to the time and date indicated in the Bid notice. The intending bidders would be required to enroll themselves on the e-procurement market-place <a href="https://tender.telangana.gov.in">https://tender.telangana.gov.in</a> Those contractors who register themselves in the e-procurement market place can download the Bid schedules free of cost. The bidder shall authenticate the bid with his digital signature certificate (DSC) for submitting the bid electronically on e-procurement platform <b>and the bids not authenticated by digital signature certificate (DSC) of the bidder will not be accepted on the e-procurement platform</b> following the G.O.Ms.No.6, I.T&amp;C Department, dated. 28-2-2005.</p> <p>(b) Intending bidders can contact office of the Chief Engineer/ P&amp;MM/ TGTRANSCO/ for any clarification / information on any working day during working hours.</p> <p>(c) The bidders who are desirous of participating in e - procurement shall submit their technical bids, price bids etc., in the standard formats prescribed in the Bid documents, displayed at e-market place. The bidders should invariably upload the statement showing the list of documents etc., in the e-market place in support of their Technical bids. The bidder should load scanned copies of all relevant certificates. The bidder shall sign on all the statements, documents, certificates, uploaded by him, owning responsibility for their correctness / authenticity.</p> <p>(d) Technical bid evaluation of the bidders would be done on the certificates/documents uploaded towards qualification criteria furnished by them.</p>
