O R D E R :

Under Regulation 14(a)(1) of A.P.S.E.Board S.Rs – Part-II, as adopted by A.P TRANSCO and as per the Hon'ble High Court's Common Order dt: 18.10.2011 in W.P.No. 29418/2010, **SEVENTY** Assistant Engineers/Elecl and **FOUR** Addl. Asst. Engineers/Elecl mentioned in the Annexure appended to this order are promoted temporarily to act as Asst. Divisional Engineers/Elecl with effect from the date of assumption of charge.

2. These promotions are in the ratio of 1:3:1 as per Note-1 of Reg. 6(b) of A.P.S.E. Board S.Rs – Part-III as adopted by A.P. TRANSCO.

3. The Inter-se-Seniority between AEs/Elecl, and AAs/Elecl, shall be fixed in the cadre of ADE/Eecl based on the results of Limited Recruitment Test to be conducted at a later date.

4. The promotions ordered in para-1 above are purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.
