2. Telangana Electricity Employees Joint Action Committee (TEEJAC) have withdrawn agitation as per agreement dated 25.10.2011 reached with Managements of APTRANSCO, APGENCO, APCPDCL & APNPDCL. Accordingly, Transmission Corporation of Andhra Pradesh Limited hereby orders that special advance to the extent of salary loss suffered on account of participation in the agitation subject to a maximum of one month salary shall be paid to the above Employees to avoid hardship to the Employees in view of the forthcoming festivals.

3. It is also ordered that the amount of advance shall be recovered as decided by the Government subsequently after consulting TEEJAC.
