Vide reference 1st cited, the Chief Engineer/ Construction-II has forwarded the copy of the letter received from the Superintending Engineer/TLC/Kurnool vide reference 2nd cited with a request to sanction an amount of Rs.5,30,046/- (Rupees Five lakhs Thirty Thousand and Forty six only) for decretal charges for the land acquired for 132 KV SS Atmakur.

Vide reference 3rd cited, the Chief Engineer/kadapa Zone/ Kadapa while enclosing the copies of Award passing proceedings, orders issued by Lower Court, High Court and Supreme Court has requested to accord approval to deposit an amount of Rs.5,30,046/- (Rupees Five lakhs Thirty Thousand and Forty six only) with R.D.O, Kurnool towards decretal charges for the land acquired for 132 KV SS Atmakur.

APTransco acquired land to an extent of Acres 3.20 guntas in Sy.No.377/1 situated at Atmakur Village, in the Atmakur Mandal for the construction of 132/33 KV Substation at Atmakur and Award was passed by the Revenue Divisional Officer, kurnool vide award proceeding No.6/94/Rc.A.3147/91, dt:27-06-1994 for total amount of Rs.90,406/- (i.e., Rs.15,000/- per Acre including 30% Solatium, 9% & 15% interest and 12 % additional market value).

After receiving the compensation, the Awardees have filed petition under section 18 of the LA Act. The Senior Civil Judge, Atmakur has enhanced the compensation from Rs.15,000/- per Acre to Rs.45,000/- per acre in O.P.No.127 of 1994. Aggrieved with the decree, the Revenue Divisional Officer, Kurnool filed in the Hon'ble High Court. The Hon'ble High Court in its judgement on 25-02-2003 enhanced the compensation from Rs.45,000/- to Rs.90,000/- per acre including all statutory benefits in A.S.No.259/2001 duly dismissing A.S.No.1245/2000 filed by the State. As per the calculation sheet of the R.D.O, Kurnool, balance 50% decretal charges for an amount of Rs.8,29,133/- has been deposited already.

Aggrieved with the Order of the Hon'ble High Court, the petitioner Bheemi Setty Nagaiah filed in Hon'ble Supreme Court of India. The Hon'ble Supreme court issued orders on 06.05.2010 enhancing the compensation rate for the land acquired from Rs.90,000/- to Rs.1,20,000/- per acre . As per the orders of Hon'ble Supreme Court of India, the Revenue Divisional Officer, Kurnool has prepared calculation sheets from 1994 to 2000 for an extent of acres 3.20 guntas in Sy.No.377/1 situated at Atmakur Village, in the Atmakur Mandal to a tune of Rs.5,30,046/- towards payment of decretal charges.

After careful consideration of the matter/ A.P.Transco hereby authorizes the Superintending Engineer/ TLC Circle/Kurnool to deposit an amount of Rs.5,30,046/- (Rupees Five lakhs thirty thousand and forty six only) with the RDO/Kurnool towards decretal charges for construction of 132/33 KV Sub-station at Atmakur in Kurnool District.

The orders are issued with the concurrence of Director (Finance & Rev.) vide Regd.No2058., dt.23.05.2012.
