The Government of Andhra Pradesh in the references 1st to 3rd cited have issued orders for issue of laminated identity cards to all the existing Pensioners/Family Pensioners who are already receiving the pension/ family pension to facilitate not only easy identification of the pensioner, but also to help in obtaining medical facilities etc.

2) In the T.O.O 4th cited, APTRANSCO issued orders directing all the Pension Disbursing Authorities to issue laminated identity cards to all the Pensioners/Family Pensioners of APTRANSCO in proforma prescribed in Annexure I & Annexure II of the T.O.O subject to certain conditions.

3) The Retired Officers Associations have requested to adopt the revised proforma approved by the Government of Andhra Pradesh for issue of laminated identity cards to the Pensioners/ Family Pensioners

4) After careful consideration of the matter, the Transmission Corporation of Andhra Pradesh Limited hereby directs all the Pension Disbursing Authorities to issue laminated identity cards to all the Pensioners/Family Pensioners of APTRANSCO in revised proforma prescribed in Annexure I and Annexure II appended to these orders.

5) The other terms and conditions stipulated in the reference 4th and 5th cited shall stand unaltered.

6) These orders are issued with the concurrence of the Director (Fin.&Rev.) vide Regd.No.4817, dt.17-12-2011.
