Vide reference 1st cited, the Superintending Engineer /TL & SS Circle/ Gunadala/ Vijayawada has requested to sanction an amount of Rs.10,17,892/- for the land acquired to an extent of Acres 9.33 Cents in Sy.No.892/39-3B for construction of 132/ 33 KV Sub-station at Piduguralla Village and Mandal in Guntur District towards decretal charges to be deposited with the RDO, Narasaraopet as per the judgement of the Hon'ble High Court in A.S.No.s 178 of 1999, 265 & 290 of 1998 and 1856 of 2000.

APTransco acquired land to an extent of Acres 9.33 cents in Sy.No.892/39-3B situated at Piduguralla Village and Mandal in Guntur District for construction of 132/33 KV Substation at Piduguralla and Award was passed by the Revenue Divisional Officer, Narsaraopeta vide award proceeding No.1/84 dt:25-03-1984 for total amount of Rs.1,14,448/- (i.e., Rs.10,000/- per Acre as per Government rate including 15% Solatium, 4% interest from 26.07.82 to 25.03.84).

After receiving the compensation, out of seven landowners, four persons approached the Hon'ble High Court and filed petition under section 18 of the LA Act. The Hon'ble High court issued orders on 27.07.2009 enhancing the compensation rate for the land acquired for construction of 132/33 KV Sub-station at Piduguralla from Rs.10,000/- to Rs.30,000/- per acre including statutory benefits namely 30% Solatium on the enhanced compensation and also 12% additional market value from the date of notification i.e., 31.03.1982 till to the date of taking possession i.e., 26.07.1982 and interest 9% per annum from the date of taking possession on the enhanced compensation including Solatium for one year and there after 15% per annum till realization of the amount as the Court directed the respondent (LAO), Narasaraopeta for arranging the payment of the decretal charges for a total value of Rs.10,17,892/-.

The Superintending Engineer/TL & SS Circle/ Gunadala/ Vijayawada along with the calculation sheets vide references 1st and 3rd cited requested to accord approval to deposit an amount of Rs.10,17,892/- with R.D.O, Narasaraopet towards decretal charges for the land acquired for 132 KV SS Piduguralla in Guntur District as requested by the R.D.O, Narasaraopeta.

After careful consideration of the above matter, A.P.Transco hereby authorizes the Superintending Engineer/ TL & SS Circle/Gunadala/ Vijayawada to deposit an amount of Rs.10,17,892/- (Rupees Ten lakhs Seventeen thousand Eight Hundred and ninty two only) with the RDO/Narasaraopeta towards decretal charges for construction of 132/33 KV Sub-station at Pidugurulla in Guntur District.

The orders are issued with the concurrence of Director (Finance & Rev.) vide Regd.No.3033., dt.04.08.2012.
