Vide reference 1st cited, the Chief Engineer/Rural Zone/ Hyderabad has requested to accord approval for purchase of land to an extent of Acre 0.30 guntas in Sy.No.30/64 and 31 at Suraram village at a rate Rs.20,00,000/- per acre for approach road to 220/132 KV Substation Sadasivpet duly enclosing the consent letter of Sri. D. Krupakar, new Pattadar.

In response to this office letter dated.28.11.2011, the Chief Engineer/Rural Zone / Hyderabad vide reference 5th cited has informed that as per the Tahasildar report dt.10.01.2012 the market value of the land in Sy.No.30/1 & 31 in Suraram (V) is Rs.6,00,000/- per Acre and prevailing market value of the surrounding lands is Rs.20 Lakhs to 25 Lakhs per Acre.

The 220 KV Sadasivpet SS, is to feed 132 KV Zaheerabad SS, 132 KV Singoor SS, 132 KV Sadasivpet SS, 132 KV MRF Feeder and other important 33 KV industrial consumers including Singoor Water Works (HMWW) which are facing low voltage problems and interruptions. The scheme cost of the SS is RS.50 Crores. The Sub-station site was donated by M/s MRF Ltd (present market value is Rs.02 Crores) but there is no approach road.

As the approach road is very much essential for to commissioning of the substation and to transport heavy Transformers to the Sub-staion. It is essential to purchase an extent of 30 Guntas for Rs.15,00,000/- as per the market value.

Considering the urgency and the essentiality of the issue, the superintending Engineer/TLC/Rural Circle/Hyderabad is hereby authorized to incur an expenditure of Rs.15,00,000/- Lakhs (@ Rs.20,00,000/- Lakhs per Acre) towards purchase of land admeasuring 0.30 Guntas in Sy.No.30/1 and 31 (V) at Suraram Village, Sadasivpet Mandal, Medak District.
