Vide reference 1st cited, the Superintending Engineer/TLC/ Rural circle/ Hyderabad was authorized to deposit an amount of Rs.14,00,000/- Lakhs (Rupees Fourteen Lakhs only) towards the payment of ex-gratia/development charges for alienation of Govt Assigned land to an extent of Acres 7.00 in Sy.No.8 at Brahmanapally Village, Madgul Mandal, Mahaboobnagar District for erection of 132/33 KV Substation at Madgula.

Vide reference 2nd cited, the Chief Engineer/Construction-I has forwarded the letter received from the Superintending Engineer/TLC Circle/Hyderabad with a request to arrange payment of Rs.7.50 Lakhs for acquiring land of Acres 5.00 guntas in Sy.No.40/35 of Madugala (V&M) for erection of 132/33 KV Substation at Madgul as requested by the District Collector, Mahaboobnagar.

In the reference 3rd cited, the Superintending Engineer /TLC/Rural Circle/ Hyderabad has requested for sanction of an amount of Rs.7.50 lakhs to deposit with the Revenue Authorities for revised proposals of Ac.5.00Gts @Rs.1.5lakhs per acre towards payment of Exgratia to the Assignees of the site in Sy.No.40/35 of Madgula Village for construction of 132/33 KVSS Madgula in Mahaboobnagar (District) in place of the earlier proposed site in Sy.No.8 at Brahmanpally Village.

After careful consideration of the above proposal made, APTRANSCO here by authorizes the Superintending Engineer/TLC/ Rural Circle/Hyderabad to deposit an amount of Rs.7,50,000/- (Rs. Seven lakhs fifty thousand only) @ Rs.1,50,000/- (One lakhs fifty thousand only) per Acre with Revenue Authorities to an extent of 5 Acres towards payment of Exgratia to the Assignees in Sy.No.40/35 of Madgula Village for construction of 132/33 KV SS Madgula in Mahaboobnagar District by superceding the TOO issued vide ref 1st cited.


