The Chief Engineer/Civil/AP Transco has submitted proposals to take up the work of "Raising of compound wall (south side), water supplying arrangements to Earth pits and metal spreading in the switch yard at 132/33 KV SS Mahaboobnagar in Mahaboobnagar Dist" as per the field requisition.

AS per the inspection report and recommendations of quality assurance wing the following works are proposed to take up at 132 KV SS Mahaboobnagar.

1. "Raising of compound wall (south side), as the height of the compound wall is not sufficient to safe guard the sub-station.
2. Water supplying arrangements to Earth pits.
3. Metal spreading in the switch yard.

The AP Transco after careful consideration of the above proposal accords administrative sanction for the work "Raising of compound wall (south side), water supplying arrangements to Earth pits and metal spreading in the switch yard at 132/33 KV SS Mahaboobnagar in Mahaboobnagar Dist" for an amount of Rs.26,49,000/- (Rupees Twenty six lakhs Forty Nine thousand only)
