APCPDCL has proposed for erection of 220/132 kV substation at Dharmavaram in Anantapur district to meet the load growth and to provide reliable and quality power supply for consumers in Dharmavaram area. Hence it is essential to erect 220/132 kV substation at Dharmavaram.

APTRANSCO accorded administrative approval vide T.O.O. (CE-Construction-I) Ms. No.314 Dt. 29.11.2011 for a total scheme cost is Rs.8542.00 Lakhs for erection of 220/132 kV substation at Dharmavaram in Anantapur district to meet the load growth and to provide reliable and quality power supply for consumers in Dharmavaram area.

Subsequently, Chief Engineer, Kadapa has informed that as per the Topo sheets the length of 220kV DC line from RTPP to the proposed 220 kV Sub-Station at Dharmavaram is coming up to 100 KM, 132kV DC Line from the proposed 220kV Sub-Station, Dharmavaram to the existing 132kV Sub-Station, Dharmavaram is Coming up to 9.00 KM and also informed that township is developed around existing 132kV Dharmavaram SS and no other corridor is available for taking off the lines and hence proposed to dismantle the existing 132 kV Dharmavaram – Ananthapur SC Line for a length of 2.00 KM duly erecting multi circuit towers in the same corridor of the existing line and requested to arrange for issue of revised Administrative Approval. The proposal is approved by the Technical Committee.

After careful consideration, APTRANSCO accords revised administrative approval for the above scheme at a total cost of Rs. 10262.00 Lakhs as per the break up indicated below.
