The Chief Engineer / Zone / Warangal submitted the proposal for erection of 220 KV LILO line from 220 KV Budidampadu – Bhongiri 2<sup>nd</sup> circuit to 220 KV SS Waddekothapally along with bays in Warangal district to meet the load growth and reliable supply for Warangal and Nalgonda district consumers.

Hence it is essential to erect the 220 KV LILO line from 220 KV Budidampadu – Bhongiri 2<sup>nd</sup> circuit to 220 KV SS Waddekothapally along with bays to meet the load growth in Warangal and Nalgonda district area and to relieve the over loading of the adjacent lines in Warangal and Nalgonda district and the consumers to get reliability and quality of power supply.

Chief Engineer/Construction-I formulated a scheme for erection of 220 KV LILO line from 220 KV Budidampadu – Bhongiri 2<sup>nd</sup> circuit to 220 KV SS Waddekothapally along with associated works. The scheme will be executed with financial assistance from PFC/Other financial institutions and with APTRANSCO funding in case full loan is not sanctioned by PFC/Other financial institutions.

After careful consideration, APTRANSCO accords administrative approval for the above scheme at a total cost of Rs.798.00 Lakhs as per the break up indicated below:
