**Sub:** Administrative approval for erection of 33 kV features in 132 kV Switching station at Inkollu in Prakasam district - Accorded

## T.O.O (CE-Construction-I) Ms. No.257

During the review of works in Prakasam District on 07.09.2012 by Joint Managing Director (Distribution), Superintending Engineer(operation)/APSPDCL/Ongole submitted the proposal for erection of 33 kV features at 132 KV Inkollu Switching Station in Prakasam district to give satisfactory voltage profiles to 33 kV substations in and around inkollu.

In this regard Chief Engineer / Zone / Vijayawada intimated that the Inkollu 132 kV switching station is tapping from 132 kV Ongole – Parchur line with 132 kV DC line and the 132 kV incoming supply is feeding from 220 kV Parchur SS with a maximum load of 25MW, and out going is feeded to 132 kV Ongole SS with a load of 18 MW and also the 132 kV supply is extended from Inkollu switching station to M/s. JVIL Industry with a load of 7 MW.

The 33/11 kV substations around Inkollu SS i.e 1) 33/11 kV Inkollu SS 2) 33/11 kV J.Pangulur SS 3) 33/11 kV Idupulapadu SS 4) 33/11 kV Thimmasamudram SS 5) 33/11 kV Dronadula SS are feeding from 132 kV Chirala and 220 kV Parchur substations. As the length of lines are high , voltage drop occurred to the 33 kV substations. At Inkollu 132 kV Switching Station space is available for erection of 33 kV features and the LILO line can cater the load provision of 33 kV features also. For providing 33 kV features at 132 kV Inkollu switching station the above 33/11 kV substations can be fed from Inkollu SS with satisfactory voltages and the losses can be reduced.

Chief Engineer/Construction-I formulated a scheme for providing 33 kV features in 132 kV Switching station at Inkollu in Prakasam district with 2 Nos. 16 MVA Power Transformers (released transformers) and has proposed to pose the scheme to M/s. Power Finance Corporation Ltd., New Delhi / M/s Rural Electrification Corporation Limited, New Delhi / other funding agencies for sanction of loan.

After careful consideration, APTRANSCO accords administrative approval for the above scheme at a total cost of **Rs. 418. 00 Lakhs** as per the break up indicated below:
