During the circulation of scheme for extension of supply for connected load of 16.5 MW to M/s GSN Ferro Alloys Pvt Ltd., Chegunta in Medak district, The Chief Engineer / Rural Zone has furnished feasibility report and authenticated data to extend the supply at 132 kV level to M/s. GSN Ferro Alloys Pvt. Ltd., from 132 kV Chegunta Substation which is fed from 400/220/132 kV Gajwel substation from the 132 kV bus of 132 kV Chegunta substation, through Gajwel – Chegunta 132 kV line.

In this connection Superintending Engineer / TLC/ Rural / Hyderabad furnished proposals for erection of 132 kV LILO to 400/220/132 kV Gajwel substation from existing 132 kV Gajwel – Chegunta 2nd circuit line due to anticipated right of way problems in the route in place of direct line to 132 kV Chegunta substation from 400/220/132 kV Gajwel substation.

Chief Engineer/Construction-I formulated a scheme for approval for erection of 132 kV LILO to 400/220/132 kV Gajwel substation from existing 132 kV Gajwel – Chegunta 2nd circuit line along with 2 Nos. 132 kV Bays at 400 /220/132 kV Gajwel SS and has proposed to pose the scheme to M/s. Power Finance Corporation Ltd., New Delhi/ M/s Rural Electrification Corporation Limited, New Delhi / other funding agencies for sanction of loan.

After careful consideration, APTRANSCO accords approval for the above scheme at a total cost of Rs. **Rs. 833.00** Lakhs as per the break up indicated below:
