PROCEEDINGS:

- 1. APTRANSCO has accorded approval for allowing to adopt price adjustment for Galvanized Structural steel for lines & substations, vide T.O.O.Ms.No.50, dated.10.06.2008, under 3rd cited.
- 2. An amendment was issued to T.O.O.Ms.NO.50, dated.10.06.2008, on 29.07.2008; vide T.O.O.Ms.No.87, for applying the Price Adjustment of MS Flat and Structural Steel in Substations and line works, vide ref 5th cited.
- 3. Government of Andhra Pradesh, vide GO Ms.No.1, dated.25.02.2012, has informed that in Sl.No.2(9) they observed that Departments are adopting diverse interpretations of the existing G.Os relating to treatment of price adjustment from 0 to 5%. After careful consideration, the Government of Andhra Pradesh has decided that hence forth all the departments should operate variation in rates only to the extent where it is above 5% over the estimated rates. Thus if the price excess is 10%, payment will be made only to the extent of 5% (10%-5%) since the contractor factors into his original bid his risk of absorbing the first 5% increase.
- After careful consideration, APTRANSCO accorded approval and amendment to clause No.7 (vi) of T.O.O.Ms.50, dated.10.06.2008 & Clause No.II (vi) of T.O.O.Ms.No 87, dated.29.07.2008 as follows.
 - (a) Hence forth Price adjustments is applicable for all <u>future works duly incorporating</u> <u>in tender specification</u>, with effect from the date of issue of T.O.O, the concerned

officers of APTRANSCO should operate variation in rates only to the extent where it is above 5% over the estimated rates. Thus if the price is 10% payment will be made only to the extent of 5% (10%-5%). Further the same procedure should be also followed for Negative variation.

- (b) For the time extension period due to department fault: Price variation (Both +Ve and -Ve) is applicable.
- (c) For the time extension period due to contractors fault: Only -Ve Price variation is applicable.
- 5. For all ongoing works of APTRANSCO price adjustment is applicable for structural steel & MS & GI Flat as per T.O.O.Ms.No.50, dated.10.06.2008 & T.O.O.Ms.No.87, dated.29.07.2008
