Sub: 2<sup>nd</sup> circuit stringing on 8 kM of 132kV DC/SC line between location No. 74/1 and 75 of Nidadavolu –Bhimavaram 132kV line to M/s Ravali Spinners Pvt. Ltd., and erection of 132kV DC/SC line from location No. 74/1 of Nidadavolu – Bhimavaram 132kV line to 132kV Tanuku 132kV substation - Administrative approval accorded.

APTRANSCO had approved scheme for extension of additional load 3.2 MVA to M/s. Ravali Spinners Pvt. Ltd., Khanadavili Post, Tanuku, West Godavari District (Referred to as 'the company' henceforth) in addition to the existing CMD of 3.15 MVA total aggregating CMD of 6.35 MVA at 132 kV Potential by erecting 132kV DC/SC line from Tanuku 132 kV SS to the company with 132 kV Bays at either ends on 25/02/2010. Accordingly, the works were taken up by the company by paying necessary development and supervision charges to APTRANSCO. After erecting 8 kM of 132kV DC/SC line from the Company end and also 132kV bays at the Tanuku 132kV SS and the Company end, erection of balance 2 kM of line is held up due to severe right of way problems. The company has requested APTRANSCO for permission to avail supply by temporary arrangement.

2. APTRANSCO has accorded approval for executing the following works by collecting applicable scheme cost from the Company:

a)	Erection of 132kV DC/SC line from between location No. 74/1 and 75 of Nidadavolu 220 kV SS – Bhimavaram 132 kV SS line to Tanuku 132 kV SS	2 kM	7124000.00
b)	2 <sup>nd</sup> circuit stringing of 132kV DC/SC line from tapping point of 132kV line from Nidadavolu 220 kV SS to Bhimavaram 132 kV SS to M/s Ravali Spinners	8 kM	6400000.00
	Total amount to be paid by M/s Ravali Spinners Pvt. Ltd. For APTRANSCO to take up the works:		13524000.00

3. The Company has paid an amount of Rs. 1,35,24,000/- vide Demand Draft drawn on State Bank of India, Yellareddiguda, (Hyderabad) branch, bearing No. "488864" on 02/03/2012.
4. After careful consideration, APTRANSCO accords approval for the above Scheme at a total cost of Rs. 1, 35, 24, 000/- (Rupees One Crore, Thirty Five Lakhs and Twenty Four Thousand Only)
5. "In exercise of the powers conferred under section 164 of the Electricity Act,2003 Central Act No.36, the Government of Andhra Pradesh, vide G.O.Ms.No.115 dated 07/10/2003, conferred upon the Transmission Corporation of Andhra Pradesh Limited, the Transmission licensee in the State of Andhra Pradesh, the powers for placing of the electric supply lines or electric plant for the transmission of electricity or for the purpose of telephonic or telegraphic communications necessary for the proper co-ordination of works that a telegraphic authority possessed under the provision of the Indian Telegraph Act, 1885 (Central Act 13 of 1885)."
6. The Chief Engineer/Zone/Visakhapatnam is authorised to take up the works stated at 2 (b) above duly following the departmental procedures in vogue.

7. The Chief Engineer/Zone/Visakhapatnam is authorised to take up the 8 km 2<sup>nd</sup> circuit stringing works related to LILO of 132kV line from 220kV Nidadavolu SS to 132kV Bhimavaram SS on nomination basis duly following departmental procedures in vogue.
