TOO (CE-Construction-1) Ms. No. 492 dated 28-02-2011 was issued for implementation of a number of new policies and guidelines for speeding up the execution and completion of transmission projects. The above TOO stipulates specific Qualification Requirements for participation in the bids invited under open competition on the e-procurement platform.

However, there are no such specific Qualification Requirements applicable for contractors executing turnkey projects on behalf of Bulk Load consumer or power developers who are taking up the transmission works directly by paying supervision charges to APTRANSCO. Since these transmission lines/substations also become part of APTRANSCO network after commissioning, it is necessary to ensure that these works are executed by experienced and competent contractors.

After careful examination, it is decided:

to give agency approval in respect of transmission works taken up by bulk load consumers / power developers duly ensuring the following:

- (i) The contractor shall have corresponding experience in erection of bay extensions, substations, transmission lines etc., of 110 kV or higher voltage against each of the works of the proposed scheme.
- (ii) The contractor shall possess a valid electrical A-Grade license issued by GOAP.
- (iii) The contractor should not be a black listed contractor of APTRANSCO.

This order is issued with the concurrence of Chairman and Managing Director/ APTRANSCO vide Reg. No. 2023 dated 05/07/2011.
