ORDER:

Government of Andhra Pradesh vide reference (1) has directed all the departments/PSUs/Local bodies to procure all works with an estimated cost value of Rs.10.00 lakhs and above, goods and services with an estimated cost value of Rs.5.00 lakhs and above through e-procurement only and the same is prevailing till date.

As per the present instructions, in APTRANSCO e-procurement procedure is prevailing for all procurement i.e. for both works and goods worth more than one lakh through e-procurement platform.

E-procurement is applicable for only open competitive bidding where any bidder who has registration in e-procurement can submit the bid on-line.

For the tenders under limited tendering, single bid and proprietary items, as per the purchase manual provisions with specific approval of the competent authority and as per the delegation of powers, tenders are to be submitted by the list of bidders who are approved by the competent authority.

After careful examination of the above i.e. Government of A.P. Orders issued vide reference (1) and the present procedure of APTRANSCO, It was decided in the whole time directors meeting held on 5.8.2011 to raise the limit from "Rs.1 lakh and above" to "Rs.5 lakhs and above" for all the procurement i.e. for both works and goods through e- procurement plat form.
