ORDER:

In the reference 5th cited, the CE/Kadapa Zone/Kadapa while enclosing the letter of SE/TLC/Kadapa has requested to shift one existing TLC Subdivision –IV, Anantapur to Hindupur. The SE/TLC/Kadapa has stated that, at present there are 4 subdivisions under the control of EE/TLC/Anantapur. Out of the four subdivisions, three subdivisions are filled and they are functioning with Anantapur as headquarters and fourth subdivision is vacant. Further, the SE has submitted that there are no. of works under progress and expected to commence in future in the TLC/Kadapa circle and in addition, there are wind power evacuation schemes and also works pertaining to the extension of supply to bulk load consumers like MB Smelters etc.

2. APTRANSCO after careful consideration here by orders that
 - (i) The head quarters of TLC subdivision – IV, Ananthapur existing in EE/TLC/ Ananthapur Division, shall be shifted to Hindupur.
 - (ii) The revised headquarters of 4 Sub-divisions in EE/TLC/ Ananthapur Division shall be follows.
 - a) AEE/TLC/SD-I/Ananthapur
 - b) AEE/TLC/SD-II/Ananthapur
 - c) AEE/TLC/S D-III/Ananthapur
 - d) AEE/TLC/SD-IV/Hindupur
3. These orders shall come into force with immediate effect.
