**ORDER:**

Under Regulation 14(a)(1) of A.P.S.E.Board S.Rs – Part-II, as adopted by APTRANSCO, Smt. J. Uma Rani, Divisional Engineer/Elecl., mentioned in the Annexure appended to this order is promoted temporarily to act as Superintending Engineer/Elecl., with effect from the date of assumption of charge.

2. The promotion ordered in para-1 above is purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.

3. The promotion ordered in para-1 above is without prejudice to the seniority of the Officers that will emerge after review of F.C.G List of Asst. Engineers of Electricity Department as on 1-11-1956 is finalized.

The promotion ordered in para-1 above is subject to the result of appeals filed by the retired officers of erstwhile APSEB against the judgement in W.P.No.2360-91/83 and pending in the Hon'ble Supreme Court and is also subject to result of W.P.No. 4219/78 and W.P.No.10822/2004 pending in Hon'ble High Court of A.P.

5. Smt J. Uma Rani, Divisional Engineer/Elecl on temporary promotion as Superintending Engineer/Elecl ordered in para-1 and the existing Superintending Engineers/Elecl mentioned in the Annexure appended to this order are transferred and posted to the places noted against their names.

6. The Controlling Officer is requested to relieve the above Divisional Engineer/Elecl by making local arrangements pending posting of substitute to enable her to assume charge on promotion as Superintending Engineer/Elecl at the place of posting ordered.

7. The promotee is requested to assume charge at the place of posting ordered after obtaining proper relief from the present place of working.

8. The promotee is informed that any request for change of posting will not be entertained and she shall assume charge accordingly after obtaining proper relief from the present place of working within 15 days from the date of receipt of these orders, failing which she has to forego all the rights both at present and in future for such higher post. If she fails to join duty within the time limit or evade to join duty such period till she re-joins will be treated as un-authorized absence, besides treating such period of un-authorized absence as 'DIES-NON'. She shall also be liable for disciplinary action.


