ORDER:

After careful consideration, the Transmission Corporation of Andhra Pradesh Limited hereby declares the CE/Rural Zone & SE/TL&SS/Mahabubnagar as Unit of Operations for the purpose of cadre management and authorize the CE/Rural Zone/Hyderabad and SE/TL&SS/Mahabubnagar to exercise the powers hither to exercised by the CE/TL&SS/Hyderabad Zone (now Metro Zone) and SE/TL&SS/Hyderabad (now Sangareddy) in their respective Units in accordance with the orders issued in the reference $1^{\rm st}$ to $6^{\rm th}$, $10^{\rm th}$ and $11^{\rm th}$ cited.
- 6. The Chief Engineer/Metro Zone/Hyderabad is requested to take necessary steps for separating the seniority as per rules in vogue.
