ORDER:

Under Regulation 14(a)(1) of A.P.S.E.Board S.Rs - Part-II, as adopted by A.P. TRANSCO, Sri P.R. Sundara Murthy, AE/ Telecom (on EOL) and Sri K. Srinivas, AE/ Telecom are promoted temporarily to act as Asst. Divisional Engineers/ Telecom with effect from the date of assumption of charge.

2. The promotions ordered in para-1 above are purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.

3. The promotions ordered are subject to result of appeals filed by the retired officers of erstwhile APSEB against the judgement in W.P Nos.2360-91/83 pending in the Hon'ble Supreme Court and W.P No.7074/98 and Writ Appeal No. 1104/2011 pending in the Hon'ble High Court of Andhra Pradesh.

4. Sri P.R. Sundara Murthy, AE/Telecom who is on EOL for 5 years upto 10.06.2012 shall report to the undersigned so as to issue posting orders on promotion as ADE/Telecom within the stipulated time, failing which he will lose his promotion right offer for the current panel year and his name shall be considered for promotion in the next panel.

5. Sri K. Srinivas, AE/Telecom on temporary promotion as ADE/Telecom is transferred and posted as ADE/Telecom/Nellore under the control of SE/Telecom/Vijayawada.

6. The concerned controlling officers are requested to relieve the above promotees by making local arrangements pending posting of substitutes to enable them to assume charge on promotion as Assistant Divisional Engineers/Telecom at the place of posting ordered.

7. The promotees are directed to assume charge on promotion as Asst. Divisional Engineers/Telecom at the place of posting ordered after obtaining proper relief at the present place of working.

8. The promotees are informed that any request for change of posting will not be entertained and they shall assume charge accordingly after obtaining proper relief within fifteen days from the date of receipt of the orders, failing which they have to forego all the rights both at present and in future for such higher posts. If they fail to join duty within the time limit or evade to join duty such period till they re-join will be treated as un-authorised absence, besides treating such period of un-authorised absence as 'DIES-NON'. They shall also be liable for disciplinary action.
