In the references 1st & 2nd cited, the Transmission Corporation of A.P.Limited revised the Pay scales of Workmen and other than Workmen with effect from 01-04-2006. It was also ordered therein that the House Rent Allowance shall be allowed as per the rates in Government of Andhra Pradesh.

- In the T.O.O 3^d cited, orders were issued revising the HRA ceiling limit from Rs.3,000/- to Rs.4,000/-Per month to the employees of APTRANSCO. In the T.O.O 4th cited, orders were issued for revising the rates of HRA to 30% of Basic Pay to the employees of APTRANSCO working within the limits of GHMC, subject to maximum ceiling of Rs.6,000/- per month.
- The Government of A.P. vide reference 5th cited have issued orders enhancing the maximum limit of House Rent Allowance per month to the Government employees in the revised pay scales, 2010 with effect from 01-07-2008 with monetary benefit from 01-02-2010 at the following rates.
 - (a) The existing classification of cities, Towns and the rates of allowance ordered in G.O.(P) No.230, dt.15-09-2005, G.O.(P) No.456, dt.08-12-2005, G.O.(P) No.181, dt.29-06-2006 & G.O.(P) No.10, dt.17-01-2008 of Finance (PC-I) Department, shall be retained for the purpose of admissibility of House Rent Allowance as indicated below:

- (b) The existing ceiling of House Rent Allowance Rs.6,000/- shall be enhanced to Rs.12,000/- per month in respect of employees working in the offices in the limits of Greater Hyderabad Municipal Corporation.
- (c) For other places, the ceiling of House Rent Allowance of Rs.4,000/- shall be enhanced to Rs.8,000/- per month.
- 4) After careful consideration, the Transmission Corporation of A.P. Limited hereby directs that the orders issued by the Government in the reference 5th cited shall be made applicable to the employees of A.P.Transco with effect from 01-07-2008 with monetary benefit from 01-02-2010 duly following the instructions issued by Government of A.P., Finance (PC-I) Department, in circular memo no.1040/48/A1/PC1/2010, dt.10-03-2010 with regard to the payment of HRA at the rates applicable to the places located with in 8 Kilometers periphery of the Municipal limits of the qualified Cities/ Towns.
- 5) The arrears from 01-02-2010 to 31-03-2010 on the revised rates of House Rent Allowance shall be paid in cash along with the salary for the month of April, 2010 payable in May, 2010.
- 6) These orders are issued with the concurrence of Director (Finance & Revenue) vide Regd.No.1107, dt.08-04-2010.
