ORDER

In the T.O.O.1st cited, approval was accorded for Group Janata Personal Accident Policy (GJPA Policy) offered by M/s National Insurance Co. Ltd., Hyderabad for period of 3 years from 01.12.2005 to 30.11.2008 at a premium rate of Rs.473/- per employee including agency commission and all Pay Drawing Officers were requested to deduct the said premium from the month of November 2005 salary, after obtaining written authorization from each employed person. The Group Janata Personal Accident Policy (GJPA Policy) covers the APTRANSCO employees against the risk due to accidents not only during the course of employment but also outside, such as Road Accidents, Burns due to fire, Drowning in water, Death due to current shock, Snake bite, Dog bite, Riots, Actions of Militants and Murders and also total or partial permanent disability sustained in such accidents.

- Further, M/s National Insurance Co. Ltd has also extended the date of payment of premium till 28.2.2006 by deducting from the salaries of February 2006 also for the employees if any left out after deducting the premium from January 2006 salary in order to cover all the employees and the said Company has also clarified that for the members for whom the premium is received after the last date for renewal i.e. 28.2.2006, the cover under Renewed Group JPA Policy will commence from the date of receipt of the premium in their office till its expiry i.e. 28.2.2009, as inclusions in the Renewed Policy and the Insurers are not liable for the intervening period. The said insurance Company issued the renewed policy bearing NO.550200/47/05/9600000118 on 28.02.2006 for a period of three years from 01.03.2006 to midnight of 28.02.2009. As per the policy schedule, the present renewed GJPA Policy will expire by 28.02.2009.
- 3). In the references 2nd to 5th cited, the Unions and Associations have requested to continue the Group Janata Personal Accident Policy for a further period of three (3) years, as the same is found to be beneficial to the employees. Accordingly after negotiations with M/s National Insurance Company Limited, vide reference 7th cited, the said Insurance Company has agreed to issue the policy at a premium of Rs.330/- (Rupees Three Hundred and Thirty only) including agency service charges per each employee for (3) years for the period from 01.03.2009 to 29.02.2012. The amounts of insurance cover payable under the said policy are as follows:

1. Death Due to Accident - Rs.1,00,000.00

2. Loss of Use of Two Limbs/

Sight in both eyes due to accident - Rs.1,00,000.00

3. Loss of use of one limb/

Sight in one eye due to Accident - Rs. 50,000.00

4. Permanent total disablement

due to accident - Rs.1,00,000.00

- 4). The policy offered by M/s National Insurance Company Limited, Hyderabad covers the APTRANSCO employees against risk on 24 hours basis whether the employees are on duty or other wise covering accidental death/injuries due to Electrocution, Accidental falls, Road Accidents, Explosions, Drowning in water, Snake bite, Dog bite, Riots, Actions of Militants and Murders.
- 5). After careful consideration, the APTRANSCO authorizes all the Pay Drawing Officers to deduct the premium amount of Rs.330/- including agency service charges per person from the salary of November 2008 payable in the month of December 2008 to the employees of APTRANSCO, **after obtaining written authorization from each employed person,** for renewal of the said Group Janata Personal Accident Policy, to its employees for the period from 01.03.2009 to 29.02.2012 **commencing from 01.03.2009** and they are requested to arrange to remit the amount recovered from the employees to the Divisional Manager, M/s National Insurance Company Limited, Division Office II, 3rd floor, Regency House, Somajiguda, Hyderabad-500082. The Specimen Form of Authorization is enclosed herewith.
- 6). Sri. K. Srinivas Reddy, Agent, Hyderabad (Cell.No. 97040-00038) will render agency services on behalf of M/s. National Insurance Company Limited during the above policy period.
- 7). All the Controlling Officers are requested to give wide publicity among the employees for awareness of the above said policy and keep it in the notice board for information.
- 8). These orders are issued with concurrence of Director (Fin & Rev) vide Regd.No.2835, dt.24.10.2008.
