ORDER:

In B.P.1st cited, orders were issued introducing the revised billing system. As per reference 2nd cited, the Bill Collectors and Sub-Inspector of Bill Collectors were re-designated as Revenue Cashiers and Sub-Inspector of Revenue Cashiers respectively duly allowing them the pay scales equivalent to that of LDC and UDC respectively w.e.f. 1.5.1982. In the B.P.3rd cited, orders were issued integrating the cadres of Revenue Cashiers and LDCs into one cadre and Sub Inspector of Revenue Cashiers and UDCs into one cadre. Accordingly, in the B.P.4th cited, amendments were issued to APSEB Service Regulations Part-III.

- 2. In B.P.5th cited, the qualification for the post of LDC has been substituted by adding note. As per note, the Bill Collectors who were in service prior to 11.07.1974 were exempted from possessing graduation qualification provided they have SSLC/HSC qualification and a minimum of 5 years service. The benefit was extended to those who acquired SSLC/HSC qualification after 11.7.1974. As per note-2 under Column-3 against the post of J.A.O. under method of promotion non-graduate Revenue Cashiers from integrated list of LDCs and Revenue Cashiers promoted to the cadre of UDCs are required to acquire graduation qualification for promotion to the post of JAO.
- 3. During the discussions held with Unions on 27-10-2008 and 29-10-2008 a consensus decision was taken and it was decided to grant one time exemption from possessing graduation qualification to the Bill Collectors/ Revenue Cahiers who were appointed after 11.07.1974 and presently working as UDCs and passed all the Departmental tests prescribed for promotion to the post of JAO.
- 4. After careful consideration, the Transmission Corporation of A.P.Limited in exercise of the powers referred to in Regulation 41 of APSEB Service Regulations Part-II as adopted by A.P.Transco and Rule 7 of the Andhra Pradesh Electricity Reforms (Transfer Scheme) Rules, 1999 in relaxation of Note-2 under Colum-3 agains the category of Accountant (Now JAO) in Annexure-III referred to in Regulation-14 of APSEB Service Regulations Part-III as adopted by A.P.Transco hereby orders that the Bill Collectors/Revenue Cahiers who were appointed after 11.07.1974 and presently working as UDCs shall be considered for promotion to the post of JAO duly exempting them from possessing the graduation qualification subject to the following conditions:
 - i) They must pass all the departmental tests prescribed and shall possess minimum service required for promotion to the post of JAO as prescribed in APSEB Service Regulations as adopted by A.P.Transco.

- The exemption now granted is only for promotion to the post of JAO, not ii) for further promotions.
- The exemption is accorded to the candidates as per their seniority, iii) suitability, eligibility etc. to the post of J.A.O.
- These candidates shall be considered for promotion in the vacancies iv) other than vacancies reserved for direct recruitment (i.e. 25% of sanctioned posts) duly following rule of reservation as per the rules in vogue.
- The exemption is applicable to the candidates referred above for filling up v) of the vacancies of J.A.O existing and future vacancies arising on or after the date of issue of these orders.
- All the Chief Engineers/Superintending Engineers are requested to take action 5. accordingly.
- 6. These orders shall come into force from the date of issue of this order.
