## ORDER:

The erstwhile APSEB based on Government Orders vide reference 1<sup>st</sup> cited has issued orders in B.P. 2<sup>nd</sup> cited to deduct an amount of Rs.5/- and Rs.10/-from the salary of December payable in January, of the "workmen" and "other than workmen" respectively every year effective from December, 1992, as their contribution towards Flag Day Fund is to be utilized for the Welfare Schemes of Ex-servicemen.

- 2. In the G.O.5<sup>th</sup> cited above, the Government of A.P. have ordered enhancing employees contribution for Flag Day Fund and issued instructions for deducting Rs.20/- & Rs.50/- per head from the salaries of Non-Gazetted officers and Gazetted officers respectively every year from the salary of each employee for the month of December payable in January effective from December 2007 as their contribution towards Flag Day Fund is to be utilized for the Welfare Schemes of Ex-servicemen.
- 3. The Transmission Corporation of A.P.Limited after careful consideration and in supercession of the orders issued in B.P.(P&G) Ms.No.603, dt.07-01-1993 directs that:
  - i) An amount of Rs.20/- & Rs.50/- per head shall be deducted from the salary of Workmen & Non-workmen respectively for the month of December payable in January every year, effective from December 2007 as their contribution towards Flag Day Fund is to be utilized for the Welfare Scheme of Ex-servicemen
  - ii) The amount so deducted shall be remitted to Director, Sainik Welfare, Gruhakalpa premises, M.J.Road, Nampally, Hyderabad-500001 through a Demand Draft.

- 4. All the Pay Drawing Officers of APTRANSCO are requested to deduct the differential amount of Rs.15/- and Rs.40/- from the salary of Workmen & other than Workmen respectively towards employees contribution for the year 2007 from the salary of December 2008 payable in January 2009 and remit the amount to the **Director**, **Sainik Welfare**, **Gruhakalpa premises**, **M.J.Road**, **Nampally**, **Hyderabad-500001** through a Demand Draft.
