ORDER:

- 3. The employees Unions have represented to extend the pensionary benefits duly considering NMR service for the purpose of pension and pensionary benefits to those who were retired prior to 01.02.2006 also.
- 4. During the CMDs meeting held on 08-07-2010, the matter was discussed and it was decided to extend the benefit of pension portion only to the employees who were retired prior to 01.02.2006 and to give monetary benefit from 01.04.2010 subject to the terms and conditions laid down in the references 1st to 4th cited.
- 5. The APTRANSCO after careful consideration decided to extend the payment of pension portion only to the employees who are having NMR service and retired prior to 01-02-2006 with monetary benefit w.e.f. 01.04.2010 subject to the terms and conditions laid down in the references cited. No revision of Gratuity and Commutation of Pension shall be allowed to the employees retired prior to 01-02-2006.
