O R D E R:

In the reference 1<sup>st</sup> cited, orders were issued enhancing for reimbursement of tuition fees for the children of Workmen of APTRANSCO from Rs.300/- to Rs.400/- per annum per pupil for classes 1<sup>st</sup> to Xth, Nursery, LKG, UKG, classes and up to Graduation level for those workmen who are in the pay scale of 2006 of Rs.9085-290-9955-355-11730-420-13830-500-16330-575-18630 and below limiting to Two children of the workmen.

2. The Govt. of AP, in G.O.Ms.No.2, dated.05.01.2011, issued orders enhancing the reimbursement of tuition fees from Rs.400/- to Rs.1000/- per annum per pupil, to the children, not exceeding two, of all the Class IV employees and Non-Gazetted Officers studying in all classes from LKG to Intermediate/12<sup>th</sup> Class.

3. After careful examination of the matter, the APTRANSCO hereby adopts the G.O. and accords approval that reimbursement of tuition fees for the children of workmen in APTRANSCO be enhanced from Rs.400/- to Rs.1000/- per annum per pupil for classes from LKG to Intermediate/ 12<sup>th</sup> Class for those workmen who are drawing in the pay scale of 2010 of Rs. 15115-485-16570-590-19520-700-23020-830-27170-955-30990 and below which is the scale corresponding to the pay scale of 2006 of Rs. 9085-290-9955-355-11730-420-13830-500-16330-575-18630 subject to the condition that the scheme should be limited to two children of the workmen.

4. The concession of the reimbursement granted in (3) above is with effect from the academic year 2011-2012.

5. The concession is subject to condition that the reimbursement should be made only on production of original fees receipts obtained from the Head Master/Principal of the School/College in cases where management of School/College do not provide free education. This reimbursement should not be made against any consolidated fees certificates for the entire year issued by any educational institution. The Concession is also subject to the other conditions imposed if any earlier in the matter.

6. This order issues with the concurrence of the Director (Finance & Revenue) vide Regd. No.2529, dt.02.07.2011.
