ORDER:-

The erstwhile APSEB in B.P. 2nd cited, based on the orders issued by Government of A.P. in G.O. 1st cited, have issued orders that the Board Employees and Government Employees on deputation in the Board who are working in Scheduled Areas as notified by the State Government shall be entitled to rent free accommodation and where such accommodation has not been provided for them, they shall be allowed to receive additional HRA for the period during which they are not provided rent free accommodation @ 10% of their basic pay in the scales of pay of 1986 subject to a maximum of Rs.150/- per month. The said allowance/facility was admitted subject to the conditions mentioned therein.

2) The Sanction of Additional House Rent Allowance in lieu of rent free accommodation was extended from time to time and the allowance was revised based on the Government Orders issued from time to time.

3) APTRANSCO in T.O.O.3rd & 4th cited have revised Allowances to the Employees coming under Workmen and other than workmen categories working at various places in APTRANSCO. In the above orders, it was ordered therein that Additional House Rent Allowance in lieu of rent free quarters to the employees working in notified scheduled areas shall be revised as per the orders of Government of A.P.

4) Government of A.P. in G.O.Ms.No.121, Finance (TA) Department, dt.08-04-2010 based on the recommendations of 9th Pay Revision Commission have ordered that Additional House Rent Allowance shall be payable @ 8% of basic pay of the employee under Revised Pay Scales, 2010 subject to a maximum of Rs.1,000/- per month in cases where rent free accommodation could not be provided by the Government to the employees holding the post to which rent free accommodation shall be provided by Government as per rules.

P.T.O

5) After careful consideration, Transmission Corporation of A.P.Limited hereby orders that the Government of A.P. orders issued in G.O.5th cited shall be made applicable to the Employees of APTRANSCO who are working in notified scheduled areas as declared by the Government of A.P. from time to time and the said Employees shall be sanctioned Additional House Rent Allowance in lieu of rent free quarters @ 8% of basic pay of the Employee in Revised Pay Scales, 2010 of APTRANSCO, subject to a maximum of Rs.1,000/- per month in cases where rent free quarters could not be provided for those Employees who are eligible as per existing rules.

6) These orders shall come into force with effect from 01.04.2010.

7) These orders are issued with the concurrence of Director (Finance & Revenue) vide Regd.No.2802, Dt.09.08.2010.

ALLOWANCES – Recommendation of Ninth Pay Revision Commission - Sanction of Additional House Rent Allowance in lieu of Rent Free Quarters in Revised Pay Scales, 2010 - Orders - Issued.

ORDER:

Based on the recommendations of Pay Revision Commission, 2005 orders were issued in the Government order first read above, to the effect that an employee holding a post to which rent free accommodation is admissible and who is not provided with such accommodation, shall be eligible to draw Additional House Rent Allowance at 8% of the basic pay subject to a maximum of Rs.500/- per month.

2. Based on the recommendations of the One Man Committee in the Government order second and third read above, orders were issued to continue the Additional House Rent Allowance in lieu of rent free accommodation to be applicable to all those employees working in Scheduled Areas on par with the employees working outside the Scheduled Areas.

3. In the Government Order forth read above, based on the recommendations of Ninth Pay Revision Commission, orders were issued implementing the Revised Pay Scales, 2010 to the State Government Employees.

4. Among others, the Ninth Pay Revision Commission has reviewed the Additional House Rent Allowance and recommended to continue to pay the said allowance at 8% of the basic pay subject to a maximum of Rs.1,000/- per month.

5. Government have decided to accept the recommendation of Ninth Pay Revision Commission and hereby order that Additional House Rent Allowance, shall be payable at 8% of the basic pay of the employee under the Revised Pay Scales, 2010, subject to a maximum of Rs.1,000/- per month in cases where rent free accommodation could not be provided by the Government to the employees holding the posts to which rent free accommodation shall be provided by Government as per rules.

6. The above benefit of enhancement in para 4 is not available for those employees eligible for Additional H.R.A. and who opt to continue to draw pay in Revised Pay Scales, 2005 or Revised U.G.C. Pay Scales, 2006. They shall continue to draw Additional H.R.A. as per G.O. 1st read above.

7. These orders shall come into force with effect from **01.04.2010**.

8. Necessary Amendments to Andhra Pradesh Public Employment (House Rent Allowance) Rules, 1988 and Manual of Special Pays and Allowances shall be issued in due course.
