**ORDER:**

APTRANSCO has been conducting Departmental Tests for its Employees and the Employees of APGENCO & DISCOMS twice every year. As per the T.O.O under reference cited, Rs.125/- is being collected by way of DD from all the employees towards the Application form & Examination Fee, Rs.25/- for each paper for recounting of marks and Rs.25/- for issue of memorandum of marks. These rates were approved during the year 2000 i.e, 10 years ago.

In view of increase in cost of stationery and other contingent expenses viz. postage, remuneration charges to Examiners and staff, typing works, printing of results in A.P. Gazette, the CGM(HRD&Trg.) has submitted proposals for revision of Examination fee and fee for issue of Memorandum of Marks and further proposed to dispense with the process of recounting of marks.

After careful consideration, the proposal of CGM(HRD&Trg.) is agreed and approval is accorded for the following rates towards the examination fee and fee for issue of memorandum of marks for each of the Departmental Examinations being conducted by APTRANSCO from the session of December, 2010 onwards. Further, the procedure of Recounting of marks has been dispensed with from the session of December, 2010 onwards.
