#### ORDER:

In the reference first cited, the Chief Engineer/Transmission issued instructions for engaging contract labour on contract basis through contract agency from the list provided by the employment exchange in respect of new substations/works and also for additional man power to man the substations.

- It has been brought to the notice that certain difficulties are being encountered by the contractors in getting the list from the employment exchanges as employment exchanges are insisting for a letter from the principal employer i.e. APTRANSCO and DISCOMs directly so as to furnish the list. In almost all the districts, the employment exchanges have not furnished the list to the contractors due to which the process of taking the operators for manning the newly commissioner substations has been stalled. In many districts, though the substations have been commissioned, they were not put in operational use due to lack of man power in APTRANSCO and DISCOMs. Also there are certain legal problems being encountered, since in some of the cases DISCOMs/ APTRANCO have already entered contractual agreement with the contractors without stipulating the clause that the candidates should be sponsored from employment exchanges in the contract conditions. Some of the contractors have also approached the Hon'ble High Court in this regard.
- 3) Therefore, It is necessary to have a thorough discussion and deliberations on the procedure to be adopted for taking the people for manning all the new substations by APTRANSCO and DISCOMs.
- 4) After careful consideration, the APTRANSCO hereby constitutes a committee with the following Officers to have a thorough discussion and deliberations on the procedure to be adopted for taking the people for manning all the new substations by APTRANSCO and DISCOMs.
