ALL INDIA SERVICES — Payment of deputation allowance to the Officers working in Public Sector Undertakings/Corporations etc. owned by State Government - Orders -

> From the Government of India, Ministry of Personnel, PG and Pensions, DoP&T, New Delhi Office Memorandum No. 2/22(B)/2008-Estt.(Pay.II), Dated: 3.9.2008.

### ORDER:

A separate set of terms and conditions are being issued to the All India Service Officers deputed to the Corporations/Public Sector Undertakings etc. owned by the State Government, wherein no provision for payment of deputation allowance is provided for in the said terms and conditions. Certain I.A.S. Officers have approached the Hon'ble Central Administrative Tribunal, Hyderabad Bench for a direction to the State Government for payment of deputation allowance on par with All India Service Officers working in the Central Government Public Sector Undertakings in pursuance of the orders issued in the O.M. read above. The Hon'ble Tribunal in its order dated 23.6.2008 directed the respondents to pay deputation allowance to the officers who approached the Tribunal.

- 2. After careful examination of the matter, it has been decided to implement the orders issued by the Government of India, Department of Personnel and Training, New Delhi vide Office Memorandum read above, regarding deputation allowance to all the All India Service Officers working on deputation to Public Sector Undertakings, Corporations, etc. with immediate effect.
- 3. Accordingly, Government hereby issue the following amendment to Item (1) of the Terms and Conditions being issued to the All India Service Officers who are on deputation to PSUs/Corporations.

## **AMENDMENT**

- 1. PAY AND ALLOWANCE: The Officers shall be paid his grade pay in the Seniortime/JG/Selection Grade/Supertime/Above Supertime Scale of IAS, admissible to him from time to time in the State Government. He shall be paid deputation allowance of 5% of the basic pay subject to a maximum of Rs.2,000/- in case of deputation within the same station and at the rate of 10% of basic pay subject to a maximum of Rs.4,000/- for other places.
- These orders shall come into force with immediate effect
- 5. This order issues with the concurrence of Finance (FR.II) Department, vide their U.O.No.5506/111/FR.II/2011, Dated: 9.3.2011.
