ORDER:

Under Regulation 14(a)(1) of A.P.S.E.Board S.Rs - Part-II, as adopted by A.P TRANSCO, Sri V. Manoj Naidu, Assistant Engineer/Civil is promoted temporarily to act as Asst. Executive Engineer/Civil with effect from the date of assumption of charge.

2. The promotion ordered in para-1 above is purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.
3. The promotion ordered above is subject to the result of Writ Appeal filed by the retired officers of erstwhile A.P.S.E. Board against the judgment in W.P No.2360-91/83 and pending in the Hon'ble Supreme Court and the promotion is also subject to result of Writ Petitions pending in the Hon'ble High Court of A.P., regarding seniority.
4. Sri V. Manoj Naidu, AE/Civil O/o EE/TLC/Division/Tirupathi on temporary promotion as AEE/Civil is transferred and posted to the control of CE/Zone/Kadapa.
5. The Controlling Officer is requested to relieve the above promotee by making local arrangements pending posting of substitute to enable him to assume charge on promotion as Asst. Executive Engineer/Civil at the place of posting ordered.
6. The promotee is requested to assume charge on promotion at the place of posting ordered after obtaining proper relief at the present place of working.
7. The promotee is informed that any request for change of posting will not be entertained and he shall assume charge accordingly after obtaining proper relief within fifteen days from the date of receipt of these orders, failing which he has to forego all the rights both at present and in future for such higher posts. If he fails to join duty within the time limit or evades to join duty such period till he re-joins will be treated as un-authorized absence, besides treating such period of un-authorized absence as 'DIES-NON'. He shall also be liable for disciplinary action.


