## **ORDER:**

In the reference 2<sup>nd</sup> cited, the Retainer Fee of Board Legal Counsels (BLCs) appearing before Courts at District Level was enhanced from Rs.3,500/- to Rs.5000/- (Rupees Five Thousand only) per month.

- 2. Pursuant to the requests of BLCs, the matter of enhancement of monthly retainer fee of BLCs was discussed in the TSPCC meeting held on 17-05-2018. After careful consideration, it was decided to enhance the retainer fee to Board Legal Counsels (BLCs) from Rs.5000/- to Rs.10,000/- (Rupees Ten Thousand only) per month.
- 3. In accordance with the said decision of Board of TSPCC, TSTRANSCO/TSPCC hereby enhances the **monthly retainer fee** to the **Board Legal Counsels** (BLCs) appearing before Courts at District Level from Rs.5,000/- to **Rs.10,000/-** (Rupees Ten Thousand only). The applicable taxes from time to time on the payments to the BLCs shall be remitted to the Government.
