TGTRANSCO – IR – Payment of Employees Compensation to Dependent Legal Heir of Deceased Artisan Late Sri B.Shankar, Artisan Grade-II, O/o.SE/OMC/Karimnagar who was expired while on service due to electrical accident on 01.10.2025 while carryout maintenance works in 132/33 KV Huzurabad SS – Sanction – Accorded.

ORDER:

In the reference 2nd cited, the Chief Engineer/Transmission/VS/Hyderabad has enclosed the detailed report of Chief Engineer/Karimnagar Zone/Karimnagar which was furnished by Superintending Engineer/OMC/Karimnagar on fatal accident occurred on 01.10.2025 in 132/33 KV Huzurabad Substation. It was informed that Sri B.Shanker, Artisan Grade-II got electrocuted while climbing the ladder and touching the Amudalapally breaker and fallen down while carryout the works for rectification of red hot on R-Phase CT stud clamp towards line side of 33 KV Amudalapally feeder at 132/33 KV SS Huzurabad on 01.10.2025 and expired due to electrocution.

2. Smt.Boda Swathi, W/o.Late Boda Shanker vide representation dated 15.10.2025 has submitted that her husband has expired while carrying out maintenance works in Substation and requested to sanction exgratia and other benefits as per eligibility.

3. The Artisans and their dependents shall be entitled for payment of compensation under Employee's Compensation Act 1923 subject to conditions mentioned therein in case of injury, disability or death by fatal accidents arising out of and in the course of employment as per the Standing Order No.21 of Chapter-VI under heading "Employee Compensation" of "Standing Orders, Service Rules & Regulations for Artisans".

4. After careful examination, TGTRANSCO hereby accords sanction a sum of Rs.14,01,750/- (Rupees Fourteen lakhs one thousand seven hundred and fifty only) as Employees Compensation as per the provisions contained in "the Employee's Compensation Act,1923" towards final settlement to Legal Heir of Late Sri B.Shankar, Artisan Grade-II, I.D.No.50003100 who was expired on 01.10.2025 due to electrocution while carryout maintenance works in 132/33 KV Huzurabad SS.

5. The Chief Engineer/Karimnagar Zone/TGTRANSCO/Karimnagar is directed to take necessary action subject to the following conditions.

- a) Legal Heir certificate shall be obtained from the dependents of deceased Artisan issued by the concerned Government Authority.
- b) An undertaking from the legal heir of the deceased worker shall be taken to the effect that there shall be no further liability to TGTRANSCO.
- c) Departmental Officers should make the actual payments directly to the legal heir and utmost care must be taken to ascertain the legal heirs. Proper receipts should be taken expressly reciting that the amount is received in full by the Legal Heir as final settlement of claims against the TGTRANSCO.
- d) The payment should be made without admitting an legal liability

6. The Chief Engineer/Karimnagar Zone/TGTRANSCO/Karimnagar is requested to request the Legal Heir of Sri B.Shanker to approach the concerned branch of State Bank of India where the deceased Artisan was holding Salary Account under Corporate Salary Package for processing the application and taking further necessary action on sanction of Complimentary Personal Accident Insurance under Corporate Salary Package as per the eligibility. The Chief Engineer/Karimnagar Zone/Karimnagar is further requested to obtain job proposals from the dependent family member of Sri B.Shanker, Artisan Grade-II along with necessary mandatory certificates/documents for examining compassionate appointment as per eligibility.
