### ORDER:

The Transmission Corporation of Telangana Limited hereby accords sanction for revision of rates of Dearness Allowance to all the Employees/Artisans and Dearness Relief to the Pensioners/Family Pensioners of TGTRANS CO in the Revised Pay Scales 2022 with effect from 01.07.2025 as indicated below:

#### (i) Dearness Allowance to the Employees/Artisans :

DA rates from 01.01.2025	Revised D.A rates from 01.07.2025
16.018% of pay	17.651 % of pay

#### (ii) Dearness Relief to Pensioners/Family Pensioners:

DR rates from 01.01.2025	Revised D.R rates from 01.07.2025
16.018% of pension/ family pension	17.651 % of pension/ family pension

2. The Dearness Allowance as per the increased rates shall be paid in cash along with the salary from the month of December'2025 payable in January'2026 to all the Employees/Artisans of TGTRANS CO. The Dearness Allowance arrears for the months of July'2025 to November'2025 shall be paid in five (5) monthly installments starting from the month of December'2025 payable in January'2026.

3. The Dearness Relief as per the increased rates shall be paid in cash along with the pension/ family pension from the month of December'2025 payable in January'2026 to all the Pensioners/ Family Pensioners of TGTRANS CO. The Dearness Relief arrears for the months of July'2025 to November'2025 shall be paid in five (5) monthly installments starting from the month of December'2025 payable in January'2026.

4. The Dearness Allowance so calculated shall be rounded off to the nearest rupee and Dearness Relief so calculated shall be rounded off to the next higher rupee.
