**ORDER:**

In the T.O.O. 3<sup>rd</sup> cited, orders were issued for payment of Variable Dearness Allowance (Cost of Living Allowance) to the Outsourced Labour of O&M of EHT Substations and to the private security guards at certain EHT substations in TGTRANSCO w.e.f. 01.04.2025 to 30.09.2025.

2. In the reference 4<sup>th</sup> cited, the Commissioner of Labour, Labour Department, Government of Telangana has notified that CPI points were increased from 1939 points to 1941 points (2 CPI points were increased) payable under Minimum Wages Act, 1948 and requested to implement the revised VDA w.e.f 01.10.2025 to 31.03.2026.

3. After careful consideration, Transmission Corporation of Telangana Limited hereby accords approval for payment of Variable Dearness Allowance (Cost of living allowance) to the outsourced labour for O&M of EHT Sub-stations and to the private security guards at Certain EHT Sub-Stations in TGTRANSCO with effect from 01.10.2025 to 31.03.2026 as detailed below:


